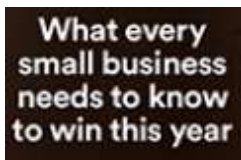

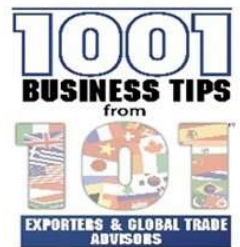

To insert the date, hold Alt Shift D / **To insert time**, hold Alt Shift T.
To translate a document, click on Review, then Translate, choose a section or the entire document, then choose a language.
Convert .pdf to Word – click in Insert / Object / Text from file / select the .pdf file / Insert. Done, editable Word document created.
To see all keyboard commands – View / Macros / View macros / type listcommands / Run / Current keyboard settings / OK. There they all are!

Use SSL (secure sockets layer) protected website. SSL establishes a secure connection on the website to transmit essential data from the server to the client and vice versa. This technology allows sensitive information such as credit card numbers, social security numbers, and login credentials to be securely sent. The data sent has been encrypted and scrambled to make it difficult for hackers to access. SSL also serves as authentication, which means SSL will ensure the data is secure when you send the information to the right server.

Some Excel tips you may find useful

- * **To learn lots of tips in Excel.** Open 'Help' in Excel and type 'Keyboard shortcuts'. Then, 'Get help on shortcuts'. There they all are Go for it!
- * **To quickly total all rows and columns in Excel** ... highlight all the numbers, including the totals required in rows and columns and press Alt and = DONE!
- * **To create an instant chart in Excel** – highlight all the data, press Alt and F1
- * **To automatically adjust column width as you type** – click on the Sheet (bottom left), click on View Code, change General to Worksheet, enter – cells.EntireColumn.Autofit and close ... done.
- * **Insert check boxes.** Highlight the appropriate cells. Hold Alt and type NCB.
